Registration for Spring 2010 Baseball & Softball

Registration for the 2010 spring baseball and softball season will be held in **November** and **December**. Late registrations received after December 13, 2009 will be assessed a late fee of \$10.00. Deadline for registrations is January 31, 2010.
